3 matters. SAP maintains books and records of entities and persons with which it has
4 contracts, agreements, and/or other substantive business relationships, such the
5 purchase and sale of a product or service, making an investment, or entering into an
6 alliance or partnership, including authorized uses by third parties of its trade name,
7 trademarks, and service marks. SAP also maintains books and records of entities and
8 persons with which it has engaged as an employee, vendor, contractor, or consultant.
9 For the purposes of this declaration, as a Senior Counsel at SAP, I am the custodian
10 of those records or am otherwise qualified to testify about them.

11 7. SAP's books and records are current as of the date of this declaration.
12 The search of these materials has not disclosed any current or past business
13 relationship of any kind between SAP and TBIS or EHI or Stollaire directly.

14 8. The search of these materials indicates that a subsidiary of SAP used the
15 services of a third party contractor to provide certain information technology ("IT")
16 services for the SAP subsidiary and that contractor subcontracted a portion of that
17 work to a subcontractor. These materials indicate that Stollaire worked as an
18 independent contractor on the IT services between late 2016 and early 2017 when the
19 contract was terminated. These materials indicate the scope of the IT services
20 involved the use of commercially available IT products and services used by the SAP
21 subsidiary, and did not include blockchain technology or digital currency.

22 9. The search of these materials has not disclosed that SAP has authorized
23 TBIS or EHI or Stollaire to use SAP's name or logo in their marketing or advertising
24 or for any other purpose. The "SAP" name and logo are the intellectual property of
25 the company. SAP considers a third-party's unauthorized use of the "SAP" name or
26 logo in marketing or advertising as an infringement of its intellectual property.


Dear Sir or Madam:
