# **DECLARATION OF CARTER CULVER**

I, Carter Culver, declare, pursuant to 28 U.S.C. § 1746, as follows:

- 1. I am employed by Exelon Business Services Company, LLC, a wholly owned subsidiary of Exelon Corporation ("Exelon"). I am a Senior Vice President, Deputy General Counsel and Assistant Secretary of Exelon. I have personal knowledge of the matters set forth below and, if called as a witness, would testify to these facts under oath.
- 2. I make this declaration at the request of the United States Securities and Exchange Commission ("SEC").
- 3. Exelon works in every stage of the energy business: power generation, competitive energy sales, transmission and delivery. As the nation's leading competitive energy provider, Exelon does business in 48 states, the District of Columbia, and Canada.
- 4. On or about February 12, 2018, the SEC requested that Exelon provide it with certain information concerning companies called Titanium Blockchain Infrastructure Services, Inc. ("TBIS") and EHI Internetwork and Systems Management, Inc. ("EHI"), and an individual named Michael Stollaire aka Michael Stollery or Michael Stoller ("Stollaire").
- 5. In my capacity as Senior Vice President, Deputy General Counsel and Assistant Secretary of Exelon, I am required, periodically and as needed, to become familiar with the entities with which Exelon has contracts, agreements, and/or other substantive business relationships including alliances and partnerships. In addition, in my capacity as Senior Vice President, Deputy General Counsel and Assistant Secretary of Exelon, I share responsibility with other members of the Exelon's legal department, intellectual property counsel, and others to protect Exelon's trade name, trademarks, and service marks from infringement and other unauthorized uses by third parties. In response to the SEC's request, and at my direction, Exelon personnel reviewed the books, records, files, and computer systems of the business units within

Exelon that might reasonably be expected to have or to have had any type of business relationship with TBIS or EHI or Stollaire including as a customer (other than possibly as a retail customer for electricity or natural gas), client, vendor, employee, contractor, consultant, or other type of business transaction.

- 6. Exelon keeps and maintains business records in the course of its transactions and regularly conducted activities as a regular practice. It is Exelon's practice to prepare such records at or near the time of the occurrence of the matters set forth by, or from information transmitted by, a person with knowledge of those matters. Exelon maintains books and records of entities and persons with which it has contracts, agreements, and/or other substantive business relationships, such as the purchase and sale of a product or service, making an investment, or entering into an alliance or partnership, including authorized uses by third parties of its trade name, trademarks, and service marks. Exelon also maintains books and records of entities and persons with which it has engaged as an employee, vendor, contractor, or consultant. For the purposes of this declaration, as Senior Vice President, Deputy General Counsel and Assistant Secretary of Exelon, I am qualified to testify about them.
- 7. Exelon's books and records are current as of the date of this declaration. The search of these materials has not disclosed any current or past business relationship of any kind between Exelon and TBIS or EHI or Stollaire directly except as noted above in paragraph 5.
- The search of these materials indicates that Exelon used the services of a third party contractor to provide certain information technology ("IT") services to Exelon and that Stollaire worked as a contractor on the IT services between July 13, 2015 and September 2, 2016, when the work ended. These materials indicate the scope of the IT services included commercially available IT products and services used by Exelon, and did not include blockchain technology or digital currency.

- 9. The search of these materials has not disclosed that Exelon has authorized TBIS, EHI, or Stollaire to use Exelon's name or logo in their marketing or advertising or for any other purpose. The "Exelon" name and logo are the intellectual property of the company with respect to energy-related products and electricity. Exelon considers a third-party's unauthorized use of the "Exelon" name or logo in marketing or advertising as an infringement of its intellectual property.
- 10. Exelon sent Stollaire a cease and desist letter on March 15, 2018, a true and correct copy of which is attached hereto as Exhibit 1. Exelon has not received a reply from Stollaire as of the date of this Declaration.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.

("Exelon Mark"). The Exelon Mark is being used on your website www.ehiinsm.com without authorization and in a false and misleading manner. Accordingly, please consider this letter as a notice of trademark and copyright infringement.

Exelon is the largest electric holding company in the United States by revenue. Since at least as early as 2000, Exelon, through its subsidiaries, has offered a broad range of energy-related products and electricity services including public utility services, energy management services, power generation, distribution and transmission of electricity and renewable energy, and related goods and services.

Your use of the Exelon Mark is unauthorized and is likely to cause consumer confusion in violation of federal law. Consumers who view the Website will have the false and misleading impression that Exelon sponsors or endorses EHI-INSM, Inc., or that there is a relationship between Exelon and the Website or EHI-INSM, Inc. when there is not.

Moreover, the Website, without authorization or permission, displays a copyrighted work owned by Exelon. Specifically, Exelon owns a copyright in the logo shown here:



("Exelon Logo"). Exelon has not granted permission for this logo to be used on the Website. The use of the logo identified above constitutes the unauthorized copy and display of an Exelon copyrighted work in violation of the Copyright Act.

Pursuant to the Digital Millennium Copyright Act ("DMCA"), this letter serves as an actual notice of copyright infringement on the <a href="www.ehiinsm.com">www.ehiinsm.com</a> website which is hosted by RackSpace, and that I and Exelon have a good faith belief that use of the copyrighted material described above is infringing and is not authorized by Exelon, its agents, or the law. A similar Notice under the DMCA will be submitted to RackSpace if you do not comply with the demands set forth below.

Accordingly, we request that you:

- 1. Immediately and permanently remove the Exelon Mark from the Website;
- 2. Confirm in writing that you will not make any further use of the Exelon Mark or any of Exelon's registered trademarks or service marks, or other intellectual property; and

This matter is urgent. Please contact me by <u>March 19, 2018</u> with respect to your intentions in this matter. If you are represented by an attorney with respect to these issues, please forward this letter to that attorney and ask that he or she contact me.

With regard to the Notice under the DMCA, I swear, under penalty of perjury, that the information in this notification is accurate and that I am authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

The foregoing is without prejudice to our client's rights and nothing contained herein shall be deemed a waiver of any such rights, all of which are hereby expressly reserved.
